Bids received after this deadline will be rejected. The bids will be opened in the presence of Bidders' representatives who choose to attend at 23-02-2022 14:00 at the office of Bagmati Rural Municipality, Bhattedada, Lalitpur. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, equal to the amount as given in the table above, which shall be valid for 30 days beyond the validity period of the bid.
