1. Bagmati Rural Municipality allocated funds towards the cost of Construction of Office Building of Bagmati Rural Municipality and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Office Building of Bagmati Rural Municipality (Contract No: NCB/BAGL/2076-077/1). Bidding is open to all eligible bidders as per Section V of Bidding Document
2. Bagmati Rural Municipality invites electronic bids from eligible bidders for the construction of Office Building of Bagmati Rural Municipality under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Rs. 8,00,00,000  
Minimum Work experience of similar size and nature: Rs. 8,50,00,000

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidder who chooses to submit their bid electronically may purchase the bidding documents from [bolpatra.gov.np/egp](http://bolpatra.gov.np/egp). 5. Pre-bid meeting shall be held at Bagmati Rural Municipality Bhattedada, lalitpur Nepal at 2076-05-24, 13:00 hours.

6. Electronic bids must be submitted to the office Bagmati Rural Municipality, Bhattedada, [Lalitpur Nepal through PPMO's e-GP system www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 2076-06-05 12:00. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2076-06-05 14:00 hours at the office of Bagmati Rural Municipality, Bhattedada, Lalitpur, Nepal. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 32,58,000 which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
