1. The Government of Nepal [GoN] has allocated funds towards the cost of **Simle Gadibhanjyang Water Supply Project Bagmati 4** and intends to apply part of the funds to cover eligible payments under the Contract for Simle Gadibhanjyang Water Supply Project Bagmati 4 (Contract No: BAGL/NCB/078/79-02). Bidding is open to all eligible bidders as per Section V of Bidding Document
2. Bagmati Rural Municipality invites electronic bids from eligible bidders for the construction of Intake structure, Reservoir Tank, Pipeline Transmission and Distribution, Pumping System under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding: Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 30000000 Minimum Work experience of similar size and nature: 25000000
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Bagmati Rural Municipality, Bhattedada, Lalitpur, Bagmati Province, Bagmati Gaupalika, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. If hard-copy is allowed then a complete set of Bidding Documents may be purchased from the office Bagmati Rural Municipality, Bhattedada, Lalitpur, Bagmati Province, Bagmati Gaupalika, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 5000.0 NRs. till 25-10-2021 00:00 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below

6. Pre-bid meeting shall be held at Bagmati Rural Municipality, Bhattedada, Lalitpur Bagmati Province, Nepal at 12-11-2021 17:00 hours.
7. Sealed or electronic bids must be submitted to the office Bagmati Rural Municipality, Bhattedada, Lalitpur, Bagmati Province, Nepal by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 24-11-2021 12:00. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 24-11-2021 14:00 hours at the office of Bagmati Rural Municipality, Bhattedada, Lalitpur, Bagmati Province, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 730000 which shall be valid for 30 days beyond the validity period of the bid.

10. Evaluation and Qualification Criteria:
General Construction Experience: Experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least last 3 years prior to the applications submission deadline.
Contracts of Similar Size and Nature: NRs. 25000000
Average Annual Construction Turnover: NRs 30000000
Required Bid Capacity: The bidding capacity of the bidder should be equal to or more than the NRs 20000000
